## NOVEMBER 15, 2010 MINUTES OF EXECUTIVE COMMITTEE MEETING

The meeting was called to order by Dave Welch. Others in attendance were Danny Case, Chrissie Powers, Peter Kimani, Tom Hrubec, Sam Smith, and Errin Linder.

The following agenda items were discussed at the meeting:

➤ The Secretary's report was delivered by Danny Case. Currently, the Central Ohio chapter has 93 members. A current

- listing of members was provided to the Board members.
- The Board had a discussion concerning when memberships are effective as there had been several members join the chapter since September who have questioned if they owes dues for 2011 since they just paid their dues. Board decided to consider all memberships paid since September 1, 2010 as 2011 memberships. The membership application was revised to include the following statement: "New Applicants: Dues paid between 10/01/10 and 12/31/10 will be applied to the following calendar year." This rule will be applied in future years.
- ➤ The Membership Committee Report was given by Tom Hrubec as follows:
  - Ideals for recruitment of new members included having a free lunch for first time visitors once or twice a year, making sure that the monthly luncheon presentations are what the members want to hear about, contacting various agencies by letter making them aware of the chapter and enclosing a voucher which could be filled out for a free lunch, Board members sending out emails inviting individuals to the monthly meetings, obtaining the attendee listing from the Emerging Trends Conference and contacting individuals who are in the central Ohio area.
- ➤ The Treasurer's report was delivered by Peter Kimani and accepted by the Board. The chapter currently has a balance of \$31,883.74 in all accounts. The Board approved payment of the invoice from the caterer for the September luncheon.
- ➤ Danny Case advised the Board that notice had been received from the Internal Revenue Service that the Chapter's application for tax exempt

- status had been approved with an effective date of September 1, 2009.
- ➤ The Training Director report was presented to the Board by Henry Smith via email as he was not able to attend the meeting.
  - a) A proposed member survey was presented for the Board's review and comments. All comments are to be made to Henry so that the final version can be made available to the members.
  - b) As of November 12, 2010 there were two applications received for the CFE Prep Course for the Class of 2011.
  - c) Henry is in the process of rewriting the commitment to be signed by new members of the classes taking the CFE Prep Course to reflect the wording contained in the now informational file used to offer members. the course to Specifically, the rewrite deals with the monetary reimbursement to be given to complete those who requirements of passing the prep course and the CFE certification exam.
  - d) Henry is still checking on the status of the three individuals in the class of 2010.
  - e) There have been no Community Projects requests received or approved by the Board to date.
- There was no update available on the status of the Chapter's new website as contact could not be made with Mike Day. Dave Welch stated that he has viewed a 30 minute webinar/tutorial from StarChapter on the website services that they offer. The cost was \$100.00 per month and \$85.00 per month if the credit card option was not selected.

- Dave indicated that he would look into having this presentation made available to the Board members.
- A brief update was given concerning the Emerging Trends Conference which will be held on May 16-17, 2011. The committees have started meeting and are in the process of obtaining speakers. Early enrollment is being encouraged since the conference had a waiting list last year.
- The License Agreements with Franklin University were submitted for the November and December meetings.
- ➤ Dave Welch presented to the Board a motion for sponsorship of general session and break-out session speaker Don Rabon from National ACFE for the Emerging Trends Conference. After discussion concerning the need for the chapter to be more involved in the conference, the Board approved this motion. Fees were stated to be \$2,500.00 and expenses to be \$700.00.
- ➤ A motion was made and approved to adjourn the meeting.

APRIL 20th LUNCHEON SPEAKER HENRY C. SMITH III OTTERBEIN UNIVERSITY

Henry C. Smith, III, graduated from The Virginia Military Institute in 1966 with a B.S. Degree in Chemistry, from Troy State University with an MBA in 1977, and then received his Ph.D. From the Virginia Commonwealth University in 1994, majoring in accounting. His certifications include

being a Certified Fraud Examiner (CFE), a Certified Management Accountant (CMA), and a Certified Controls Specialist (CCS). He is currently an Associate Professor of Accountancy at Otterbein University, teaching in the fields of management accounting, forensic accounting, and fraud examination. He has just completed developing a four course fraud track at the graduate level; that is being implemented in the Fall of 2011.

Henry began working with the Association of Certified Fraud Examiners in 1996 when there were less than ten people teaching fraud examination classes in colleges and universities across the nation. From that point on The ACFE has developed the Higher Education Program, stressing the ACFE Anti-Fraud Education Partnership. The presentation that will be given is focused on the development and growth of both the program and partnership, to include the supplemental actions taken by and materials available from the ACFE.



# **CFE Prep Course Class of 2011**

The Central Ohio Chapter of the ACFE is now accepting applications for the Class of 2011 Prep Course for CFE Certification of regular members. Submit your application by contacting Henry C. Smith, III, Training Director, at <a href="https://documents.org/henry-new-the-n

- 1. Be eligible for certification during the calendar year 2011 based upon both the education and experience requirements of the ACFE
- 2. Be a member of both the Central Ohio Chapter of the ACFE and the ACFE.
- 3. Purchase the ACFE Exam Prep Course at the current cost.
- 4. Agree to complete the course and final certification exam during the calendar year 2011.
- 5. Provide updates, as requested by the Training Director, concerning your progress toward completion.
- 6. Sign a contract with the Central Ohio Chapter of the ACFE agreeing to the above specified terms.

The Central Ohio Chapter of the ACFE Board of Directors has approved reimbursement for up to five members of the Class of 2011 for successful completion of the CFE Prep Course and CFE certification exam no later than December 31, 2011. Reimbursement is 50% of incurred out-of-pocket costs, up to a maximum of \$500.00. Reimbursement will be made only to the first 5 members to complete the exams and submit proof of completion paperwork. Completion paperwork is due prior to March 30, 2012.

### **Student CFE Prep Course Program**

The Central Ohio Chapter of the ACFE is also accepting applications from student members who would like to take the CFE Prep Course. Benefits associated with this program include:

- 1. Reduced membership fees for the Central Ohio Chapter of the ACFE (current cost of \$ 10) and the ACFE (current cost of \$ 25).
- 2. Purchase of the Student Package (current cost of \$350) that includes the CFE Exam Prep Course, a waiver of the CFE Exam fee, and the first year CFE membership dues are waived.

Submit your application by contacting Henry C. Smith, III, Training Director, at <a href="https://hcsmith@otterbein.edu">hcsmith@otterbein.edu</a>, expressing your interest in the program. Criteria for selection are the same as for regular members above.

The Central Ohio Chapter of the ACFE Board of Directors has approved reimbursement for up to five student members for the successful completion of the CFE Prep Course and CFE certification exam no later than December 31, 2011. Reimbursement is 50% of incurred out-of-pocket costs, up to a maximum of \$175.00. Reimbursement will be made only to the first 5 student members to complete the exams and submit proof of completion paperwork. Completion paperwork is due prior to March 30, 2012.

# **Chapter Officer Duties**

Below are the general duties for chapter officers. Additional duties or restructuring of duties may vary with each chapter.

#### **President**

Only a certified member of the Association of Certified Fraud Examiners who is in good standing may hold the office of President. The President shall be the executive head of the Chapter, and when present, shall preside at all meetings of the Chapter and Board of Directors. He or she shall exercise general supervision and management of the affairs of the Chapter; shall consult with and inform other Officers and Directors. Members, and the Corporation of significant events; shall make an annual report to the Members of the Chapter and the Corporation; and shall have additional duties as may be delegated by the Board from time to time.

#### **Vice President**

The Vice President shall report to the President and shall assume the duties of the President in his or her absence. The Vice President shall be responsible for other duties that the Board shall delegate from time to time. The Vice President shall be a Member of the Association of Certified Fraud Examiners in good standing. The Board may vote to allow Associate Members to hold the office of Vice President. Notwithstanding the forgoing, if the office of President becomes vacant before the expiration of the term, the Vice President may not assume that position for the unexpired term unless the individual is a Certified Fraud Examiner in good standing.

#### Secretary

The Secretary shall report to the President and shall be responsible for maintaining all records, other than financial, maintained by the Chapter. The Secretary shall also be responsible for the Membership records and

attendance; the minutes of the meetings; and other duties that from time to time may be required. The Secretary shall be a Member of the Association of Certified Fraud Examiners in good standing.

#### Treasurer

The Treasurer shall report to the President and shall be responsible for all financial records maintained by the Chapter. All moneys received by the Chapter as well as disbursements there from, shall be the responsibility of the Treasurer. He or she will ensure that any funds received are properly deposited for safekeeping to the credit of the Chapter; that all disbursements are properly approved; that the Board is kept advised of the status of the accounting of funds; and otherwise perform appropriate duties to see that the assets of the Chapter are properly safeguarded. The Treasurer shall produce annual financial statements of the Chapter and submit them to the Board and the Corporation within three months of the end of the Chapter's fiscal year. The Treasurer shall be a Member of the Association of Certified Fraud Examiners in good standing.


