#### DECEMBER 27, 2011 MINUTES OF EXECUTIVE COMMITTEE MEETING

The meeting was called to order by Heinz Ickert. Others in attendance were Danny Case, Chrissie Powers, Sam Smith, Melissa Smart, Steve Ritzer, Peter Kimani, and Henry Smith.

The following agenda items were discussed at the meeting:

The minutes of the November 15, 2011 Board meeting were approved.

- Currently, the Central Ohio chapter has 107 members.
- ➤ The Treasurer's report was reviewed and accepted by the Board. The chapter currently has a balance of \$27,955.04 in all accounts.
- ➤ Henry Smith presented the Training Director's Report stating that four members of the Class of 2011 have indicated that they will probably not finish the program based on various reasons. The five members of the Student Class of 2011 has had four completed the program and been reimbursed.
- ➤ Henry indicated that for the 2012 class he has had seven members apply. There has also been seven student members apply for the Student class.
- ➤ There have been no Community Projects approved by the Board or offered to the Community to date.
- The Board had discussions concerning the chapter's new website and the templates recently issued by National for chapter use in designing a website. Melissa acknowledged the work that had been done on the new website but raised concerns about the costs to maintain the new website verses the use of the templates from National. Peter gave a brief summary to the Board of how we got to where we are now:

The old website was out of date.

Star Chapter which is used by other chapters was reviewed but the \$900 initial set up fee and \$100 monthly fee were deemed to be more than the chapter could afford to pay on an ongoing basis.

The current web designer had an initial development cost of \$850 and covered three years of domain and hosting fees.

The Board acknowledged all the work that Peter had done in getting the new web site designed and running.

- ➤ The enhancements which had been suggested for the new web site were reviewed. A motion was made, seconded, and approved to spend \$250 for the enhancements.
- ➤ Heinz stated that he had obtained the evaluation comments that the attendees of the Emerging Trends conference had made. The comments were similar to those from previous conferences concerning the location, the number of people in a session, etc.
- A motion was made and approved to adjourn the meeting.

Danny has approximately 33 years experience in Audit Services with AEP. He was in charge of an audit crew which did operational/financial audits for Indiana Michigan Power and Michigan Power Companies from 1981 through 1996. Since that time, he has relocated to Columbus, OH and has been involved in a multitude of different activities and audits involving the customer billing system, Sarbanes Oxley compliance, and financial controls reviews. He also performs fraud investigations.

He has been a member of the Central Ohio Chapter since relocating to Columbus, and has served on the Board of Directors as Vice President, Secretary, and Board Member at Large.

### CFE PREP COURSE CLASS of 2012

The Central Ohio Chapter of the ACFE is now accepting applications for the Class of 2012 Prep Course for CFE Certification of regular members. Submit your application by contacting Henry C. Smith, III, Training Director, at <a href="mailto:hcsmith@otterbein.edu">hcsmith@otterbein.edu</a>, expressing your interest in the program. Criteria for selection:

- 1. Be eligible for certification during the calendar year 2012 based upon both the education and experience requirements of the ACFE
- 2. Be a member of both the Central Ohio Chapter of the ACFE and the ACFE.
- 3. Purchase the ACFE Exam Prep Course at the current cost.
- 4. Agree to complete the course and final certification exam during the calendar year 2012.

- 5. Provide updates, as requested by the Training Director, concerning your progress toward completion.
- 6. Sign a contract with the Central Ohio Chapter of the ACFE agreeing to the above specified terms.

The Central Ohio Chapter of the ACFE Board of Directors has approved reimbursement for five members of the Class of 2012 for successful completion of the CFE Prep Course and CFE certification exam no later than December 31, 2012. Reimbursement is 50% of incurred out-of-pocket costs, up to a maximum of \$500.00. Reimbursement will be made only to the first 5 members to complete the exams and submit proof of completion paperwork. Completion paperwork is due prior to March 30, 2013.

#### **Student CFE Prep Course Class of 2012**

The Central Ohio Chapter of the ACFE is also accepting applications from student members who would like to take the CFE Prep Course. Benefits associated with this program include:

- 1. Reduced membership fees for the Central Ohio Chapter of the ACFE (current cost of \$ 15) and the ACFE (current cost of \$ 25).
- 2. Purchase of the Student Package (current cost of \$350) that includes the CFE Exam Prep Course, a waiver of the CFE Exam fee, and the first year CFE membership dues are waived.

The Central Ohio Chapter of the ACFE Board of Directors has approved reimbursement for five student members for the successful completion of the CFE Prep Course and CFE certification exam no later than December 31, 2012. Reimbursement is 50% of incurred out-of-pocket costs, up to a maximum of \$175.00. Reimbursement will be made only to the first 5 student members to complete the exams and submit proof of completion paperwork. Completion paperwork is due prior to March 30, 2013.

#### **Additional Reimbursement Information**

The Central Ohio Chapter of the ACFE Board of Directors has also approved transfers of funds at the end of each calendar year (December 31) from the Class of 2012 (based on less than 5 members completing the course) to the Student Class of 2012 for use in reimbursing student members (in a number greater than of the first 5 student members completing the course). The amount of funds available for this action will be determined based on actual completions at the end of the year (December 31).
