The Columbus Chapter of the Association of Certified Fraud Examiners has moved heavily into the "green movement" with its upcoming year. We are embracing recycling. You may be wondering why I am writing this message instead of Dave Welch. Due to a substantial and sudden increase in personal responsibilities, Dave felt obligated to tender his resignation as President to your Board versus being unable to lead the Chapter as he desired. Our Chapter's By-laws provide that the then sitting Vice President is obliged to assume the role as President for the remainder of the resigning President's term. As you may also remember, I was elected Vice President by the Board after the elected Vice President also felt the need to resign to deal with his personal obligations. Thus, for the one year remaining in Dave's term, you have a recycled former President.

In continuing the recycling theme, your Board has decided to return the Chapter's meetings to the River Club. ## JUNE 20, 2011 MINUTES OF EXECUTIVE COMMITTEE MEETING

The meeting was called to order by Dave Welch. Others in attendance were Danny Case, Chrissie Powers, Sam Smith, Heinz Ickert and Henry Smith.

The following agenda items were discussed at the meeting:

- The Secretary's report was delivered by Danny Case. Currently, the Central Ohio chapter has 98 members. A current listing of members was provided to the Board members.
- The Treasurer's report prepared by Peter Kimani who was unable to attend the meeting was reviewed and accepted by the Board. The chapter currently has a balance of \$33,961.84 in all accounts.
- There was no Membership Committee Report as that position is currently vacant.
- Henry Smith presented a short Training Director's report stating that there had been no change since the last report in the status of the members in the scholarship program. There was a short discussion concerning the position of Student Liaison. Henry indicated that he knew of a person who would be a good candidate and would provide a Bio of the person at the next Board meeting.
- As Peter Kimani could not attend the meeting, there was no update on the new website for the chapter. However, Peter will be giving a presentation at the June 22<sup>nd</sup> luncheon covering the new website and the various features it contains.
- Dave Welch indicated that in approximately two weeks there would be a meeting of committee members of the

Emerging Trends conference. Evaluation results of the May conference should be available at that time.

- Chrissie Powers provided the Board a recap of the Chapter Leaders meeting at the 22<sup>nd</sup> Annual Fraud Conference. The chapters were advised to be aware of "StarChapter" web services as there may be more costs associated with this service than are initially anticipated. Chapter leaders were encouraged to log on their websites and to be more involved in chapter activities. As Chrissie represented the chapter at the conference, the Board agreed that she should submit her expenses to the Treasurer for reimbursement.
- Dave Welch indicated that he had been contacted by Adam Featherling who had returned to Columbus from Texas. Adam had expressed an interest in filling the open position for the Speaker's Bureau.
- > Dave Welch presented the Board members with a letter of resignation effective June 30, 2011. The Board members, in an effort to avoid having an open position after the chapter elections on June 22<sup>nd</sup>, asked Dave to consider making the resignation effective after the June 22<sup>nd</sup> luncheon. Dave agreed to this A motion was made and request. accepted by the Board to accept Dave's resignation effective after the June 22<sup>nd</sup> luncheon upon which Heinz Ickert, currently the Vice President, would fill the remaining one year of Dave's term as President.
- A motion was made and approved to adjourn the meeting.

## AUGUST 23, 2011 MINUTES OF EXECUTIVE COMMITTEE MEETING

The meeting was called to order by Heinz Ickert. Others in attendance were Danny Case, Chrissie Powers, Peter Kimani, Sam Smith, Steve Ritzer, Melissa Smart, and Henry Smith.

The following agenda items were discussed at the meeting:

- The Secretary's report was delivered by Danny Case. Currently, the Central Ohio chapter has 107 members. A current listing of members will be provided to the Board members.
- The Treasurer's report presented by Peter Kimani was reviewed and accepted by the Board. The chapter currently has a balance of \$33,657.48 in all accounts.
- Peter indicated that there is a need for someone to assume the duties associated with maintaining the new website. Peter reviewed the costs to date spent on the new website (\$1,014.15) and a list of additional features which had been suggested to be added. It was decided to wait until after the first chapter meeting before adding any new features.
- The Board welcomed new member Steve Ritzer.
- The Board had discussions concerning the location of the chapter luncheons. Some Board members indicated that they believed that the current location was not a professional setting and that some members were no longer attending. Melissa indicated that she would contact the River Club to see if a new contract could be executed. (After the meeting, the Board was advised via email that the River Club indicated that they could

work with the Chapter concerning pricing if our meetings were on a date in which they already had an event scheduled. It was stated that the Rotary Club meets on Tuesday, the day before our usual meeting date. The Board agreed via email to move the chapter meeting dates to the third Tuesday and to return to the River Club).

- The Board had discussions concerning luncheon speakers. It was expressed that a lot of the chapter members have years of experience in fraud investigations and the Board should encourage these members to share their investigative techniques, cases, etc. with the membership.
- The 2011 Emerging Trends Conference was discussed with some Board members indicating that they did not feel that the topic area of fraud was adequately covered. There was discussion concerning if the Chapter should continue participating in this annual event. It was decided that a committee will be formed to review the Chapter's options concerning this event.
- Henry indicated that National ACFE is looking at presenting a two day seminar "Auditing for Internal Fraud" here in Columbus in 2012. Dates have not been finalized but the October – November 2012 time frame is being considered. The two day seminar would offer 16 hours of fraud related CPE. The cost would be approximately \$700 (discounted).
- A motion was made and approved to adjourn the meeting.



Melissa has a BA in Criminology from The Ohio State University. She has been an investigator with JP Morgan Chase Bank since 1998, conducting both internal and external investigations related to the Bank. After spending 8 years focused on check fraud, last year Melissa joined Cross Channel Investigations, which addresses fraud issues that involve remote banking channels such as online, mobile, and telephone banking. Prior to joining Chase, Melissa was a criminal investigator for the State of Ohio. She obtained her CFE in 2004, and her CFI in 2006. She has been an active board member with the Central Ohio Chapter for several years.
