MEMBER SPOTLIGHT

Marcos Trinidad, CFE | JPMorgan Chase & Co | Vice President | Investigator | Electronic Crimes Investigations Unit | Global Investigations

Q. Tell us about your current role?

A. I have been in my current role since February 2014, performing fraud investigations involving remote channels (e.g., Internet, mobile banking, call centers) and electronic fund transfers (e.g., wire transfer or ACH). I also work extensively with law enforcement at the local, state, federal, and international level.

Q. What do you like about being an ACFE member?

A. I have been a CFE and chapter member since 2015. The ACFE provides current information on new emerging fraud trends through fraud conferences, webinars and fraud magazines. This provides significant value to my role as an investigator, which helps me stay current with relevant information about fraud. The ACFE also provides me with networking opportunities to reach out to other ACFE members within my field and/or industry.

Q. Looking back at your success throughout your career, what is the best piece of advice you can share with others?

A. Asking for help isn't a sign of weakness, it's a sign of strength. Take criticism or "feedback" for what it is: a gift given to you to make you better at what you do. Also, always take on new challenges, even if you are not sure you are completely ready.

Q. What accomplishments are you most proud of?

A. I worked on a case where I uncovered a large check fraud risk via online deposits with an exposure of about \$1.3 million, where it involved about 600 suspects. I was then involved in updating the policy and procedure regarding check remote online deposits that helped in preventing future potential loss for the bank.

Q. What do you like to do for fun?

A. Taking summer vacation with the family.

Q. What is a fun fact about you?

A. I have an identical twin brother.
