Kevin Lewis, CFE | JPMorgan Chase | Customer Claims - Escalation & Investigation Research

Q. Tell us about your current role?

A. I work in the retail claims department of Chase Bank assisting the front and back end areas of the department. Having been in the department for over 13 years, I have a good skill set to help resolve customer escalations and assist with processing and recovering lost money for our customers - internal and external.



Q. How long have you been a CFE and member of the Central Ohio ACFE Chapter?

A. I became a member since the spring 2015 and became a CFE in the fall of that year.

Q. What do you like best about being an ACFE member?

A. I enjoy having access to the resources offered by the ACFE and meeting others who share my passion for fighting fraud.

Q. Looking back at your success throughout your career, what is the best advice you can share with others?

A. My mother gave me the best career advice when I was about 8, and she had started working for the Ohio Bureau of Employment of Services. She worked there helping people find jobs, so I told her that I never wanted to work because it seemed boring (or something to that effect). She then said I never had to work if I didn't want to, so I turned to her thinking she had some secret about to get out of need to work. Playing along, my mom tells me that she does have a secret and bends down to whisper in my ear, "Find something that I really enjoyed doing and find out how to get paid for it." I had that conversation 40 years ago and can say that my mom was correct, because I love helping people understand fraud claims and that is my job.

Q. What accomplishments are you most proud of?

A. I am most proud of my 2 bachelor degrees (business forensics and forensic accounting) as well my CFE and paralegal certifications. I feel a sense of pride every time I put everything together to identify a fraudster.

Q. What do you like to do for fun?

A. For fun, I like to learn and enhance my skill set as a fraud examiner.

Q. What is a fun fact about you?

A. One week before my 16th birthday, I was hit by a car while riding my bicycle. The right side of my head crashed against the car's windshield resulting in brain damage and being paralyzed the left side of my body. Today, I help run two support groups for over a million people who have been or are caregivers of someone who has been traumatically brain damaged.
